COMPANY PROFILE

MP3 was founded in Italy in 1978. In 2016 it became **MP3 S.r.l.**, as part of the holding I.L.P.A. SPA. From when it has been founded until now the company has specialised in the supply of finished products in traditional polymers (PS, PP and PET) and also in bio plastics (PLA) in addition to products in the sheet sector (ABS, ABS/PMMA and PS).

The plant in Valsamoggia (Loc. Bazzano, BO) was built in 1998 on 45.000 m² of covered space on an overall area of 80.000m². The production capacity, result of the most modern equipment in the sector, is 72.000 Ton/year with ample margin for future growth for export. Currently the 67% of the output is addressed to export to more than 20 countries, predominantly Europe and the Middle East.

The decision to concentrate their growth in the strategic sectors of the food packaging and industrial markets has led MP3 srl to become today one of the European market leaders. The focus on diversification is one of their main strengths in a period of particular economic situation; the will is towards the investment: over 100 million Euro invested from 1998 to today to increase the production quality and diversify it for the different sectors.
